ELIGIBILITY

The following will be essential to determine your suitability as an applicant:

- Confirm your organisational eligibility.
 An incredible amount of precious time is wasted on applications from organisations who do not meet the eligibility requirements. Refer to Perpetual's Instructions and Guidelines to determine this. This document will also be helpful for the below items
- Ensure you have read the Application Conditions. These will give you guidance on how many applications you can submit. This will depend on your organisation's operational location and institution type.
- Determine whether your funding request will be deemed eligible.
 Perpetual will not provide retrospective funding, fundraising appeals or funding direct to individuals
- Ensure you have acquittal reports on activities funded in the past handy to include as part of your application.
- Consider whether the requested funds can be spent and / or project can be completed by 30 June 2022

CHECKLIST

ASSESSMENT CRITIERIA

The following assessment criteria is applied to Perpetual's Impact Funding, making it essential to answer the following questions across four assessment pillars:

- Strategy: Do you have evidence of strategic goals and demonstrable outcome-oriented measures? Can you outline your organisational strategic priorities for the next 12 months and demonstrate how your project aligns with these strategic goals?
- Outcomes: Are you able to demonstrate activity outcomes with evidence that is measurable, realistic and will provide a clear picture of the long term impact of funding? Can you confidently communicate your KPIs and measurement tools in relation to how efficiently you use your resources?
- Capability: Can you evidence your organisation's demonstrated ability to achieve its objectives with the resources available to it?
- Leadership: Are you aware of, and able to communicate your awareness of the external environment and how it relates to your organisation and project including public policy, government, other organisations working within the sector, and the community?

OTHER CONSIDERATIONS

You'll also be required to answer the following questions, which may require additional research, data collection and analysis:

- Have you done a gender analysis for the proposed project? This is particularly relevant for projects that are specifically designed to improve opportunities for women and girls or if you believe it may occur as a side benefit to your activity.
- Can you align your project with three of the 17 United Nations Sustainable Development Goals?
- Do you have risk
 mitigation strategies in
 place for at least 3 of the
 potential risks associated
 with your project or
 project?
